## SEASON PASS TERMS AND CONDITIONS

**Full Play Pass** unrestricted golf for the duration of the 2025 golf season.

**Nine Hole Full Play Pass** valid for no more than one nine-hole round per day.

**Multi Game Passes** are ***non-transferrable*** and entitle the Pass Holder to up to the number of rounds chosen at time of purchase.

- Multi Game Pass may upgrade their level at any time based on in-season rates.
- Any rounds left unused at season's end are void. ***NO EXCEPTIONS.***
- Extraordinary green fee's for Multi Game Pass holders as follows:

- 50 Game Pass \$41 for 18 holes upon completion  
\$27 for 9 holes any time
- 30 Game Pass \$50 for 18 holes upon completion  
\$32 for 9 holes any time
- Nine Hole 30 Game Pass \$42 for 9 holes upon completion  
\$42 for 18 holes with use of one nine hole round

**Osprey Small Business Partners** Once all rounds have been used, Osprey Small Business Partners may choose to purchase further rounds in increments of 10 for equivalent pricing to original purchase. Alternatively, Osprey Small Business Partners will qualify for guest green fee rates for the remainder of the season.

**Power Carts** All golf course power carts are rented on a per seat basis. It is at the discretion of the Golf Shop staff as to how seats will be administered.

Multi Game Pass holders who pre-pay for their cart seat will have one seat attached to each round

Pass holders who pre-pay for their power cart seat are required to ensure any person riding with them has paid for the use of the other seat and to read over and sign off on our power cart policy.

**Golf Canada Membership** Golf Canada Memberships are an optional add-on to all Season Pass purchases and provide several benefits beyond your certified handicap index. All Seasons Pass holders are encouraged to purchase a Golf Canada membership.

**Insurance** Season Pass Insurance must be in place prior to opening day 2025 or purchased with your season pass any time after opening day. Insurance form must be signed and dated by the insured at time of purchase.

**Pre-authorized Debit Plan** Pre-authorized debit plans are available to any pass holder who wishes to spread out the payment of their Season Pass. All pre-authorized debit plans come with a \$60 administration fee and require a valid credit card on file. Payments will be processed on or before the tenth day of each month.

**Balfour Recreation Commission** All Adult Season Passes require purchase of a BRC Membership. Those who live within the BRC catchment area, Redfish Creek to Coffee Creek are sustaining members and are encouraged to get involved with the BRC and its operations. Sustaining members will be given the right to vote at the Balfour Recreation Commission in Annual General Meeting in 2025.
